- Span received the following grants and awards so far this fiscal year:
 - o Denton County Social Services Grant for operational support \$115,471.81
 - o James Avery Grant for Operational Support \$25,000

 - o 100 Dentonites unrestricted funds \$10,000
 - o Cross Timbers Rotary (Buck a Duck) unrestricted funds \$1,258.00

• PJ reviewed the financial report for last fiscal year.

Operations Report: Max Calder

- Max reviewed reports for Meals on Wheels and Transportation services.
 - Meals on wheels program grew by 22% last year. There is still no waiting list, although this is in jeopardy as the program continues to grow with limited funding. A new congregate site will soon be added to the program.
 - o Transportation program grew by 26.76% last year. There was a 14.12% denial rate due to capacity issues with vehicles.

Human Resources and Administration Department: Julie Hydock

 - o Span currently has 79 employees. Payroll has been converted to Paylocity.
